

Gig'em Solar, LLC Service Agreement

This Service Agreement (the "Agreement") is made and entered into as of [date provided on service agreement form], by and between Gig'em Solar, LLC ("Gig'em Solar, LLC") and [Client Name provided on service agreement form] (the "Client").

WHEREAS, Gig'em Solar is in the business of providing cleaning services; and

WHEREAS, Client desires to engage Gig'em Solar to provide such services;

NOW, THEREFORE, in consideration of the mutual covenants and promises set forth herein, the parties agree as follows:

1. Services. Gig'em Solar shall provide the following services to Client the "Services":

- a. Cleaning of solar panels and related equipment;
- b. Maintenance of solar panels and related equipment;
- c. Repair of solar panels and related equipment; and
- d. Any other services requested by Client and agreed to by Gig'em Solar.

2. Payment. Client shall pay Gig'em Solar for the Services at the rate of Fees provided on Gig'em Solar website. Payment shall be due within upon date of service.

3. Term and Termination. This Agreement shall commence on the date hereof and shall remain in effect until terminated by either party.

4. Warranties. Gig'em Solar warrants that the Services shall be performed in a professional and workmanlike manner and in accordance with all applicable laws and regulations.

5. Indemnification. Client shall indemnify, defend, and hold harmless Gig'em Solar from and against any and all claims, damages, losses, liabilities, costs, and expenses (including reasonable attorneys' fees) arising out of or related to the Services provided by Gig'em Solar.

6. Limitation of Liability. In no event shall Gig'em Solar be liable for any indirect, incidental, special, or consequential damages arising out of or related to the Services provided by Gig'em Solar.

7. Miscellaneous.

a. This Agreement constitutes the entire agreement between the parties with respect to the subject matter hereof and supersedes all prior agreements and understandings, whether written or oral.

b. This Agreement may not be amended or modified except in digitally signed by Client parties.

c. This Agreement shall be governed by the laws of the State of Texas.

d. The parties agree to submit to the exclusive jurisdiction of the courts of the State of Texas for any dispute arising out of or related to this Agreement.

e. If any provision of this Agreement is held to be invalid or unenforceable, such provision shall be struck and the remaining provisions shall be enforced.

f. The headings in this Agreement are for convenience only and shall not affect its interpretation.

g. I agree to the use of the content created after my solar cleaning service successfully completes the job.
